

## **Cabral Collision Center's Lifetime Warranty**

Cabral Collision Center hereby provides a limited warranty on repairs performed. This warranty is valid for as long as you own the vehicle repaired at Cabral Collision Center under the owner's name of whom the original work order is completed. This is a labor only, fragmented four-part warranty and stipulations pertaining to each fragmented part are stated hereafter:

- 1. Metalwork: Cabral Collision Center provides a lifetime warranty effective on all metalwork and framework, to include welding and the application of materials utilized in making collision repairs against cracking, flaking, pitting, or deterioration, excluding any rust repairs. Cabral Collision Center will repair and repaint, excluding any rust repairs, any metalwork warranted hereby unless caused by or damaged resulting from unreasonable use, maintenance, care of the vehicle, or unrelated damage thereafter repairs have been made.
- 2. Painting, striping, and decals: Cabral Collision Center provides a lifetime warranty on painting-related priming and painting work against solvent blistering, peeling, hazing, and excessive loss of pigmentation and a lifetime limited warranty on the application and adhesion of decorative stripes and decals, excluding those defects which are caused by extreme environmental conditions to which the vehicle is exposed. Cabral Collision Center will reprime, repaint, restripe, or re-decal the specific section or sections of the vehicle excluding any rust repairs when a claim is made to Cabral Collision Center unless caused by or damage results from unreasonable use, maintenance, care of the vehicle, or unrelated damage thereafter repairs have been made. Paint warranty is valid only over OEM type finished that are free of defect. There is no warranty offered on decals provided by the customer.
- 3. Mechanical repairs: Cabral Collision Center provides a ONE YEAR LIMITED WARRANTY on all mechanical repairs pertaining directly to original collision damage. Cabral Collision Center will re-repair any mechanical assembly or component replaced or repaired from collision damage when claim is made to Cabral Collision Center unless caused by or damage results from unreasonable use, maintenance, care of the vehicle, or unrelated damage thereafter repairs have been made.
- 4. Parts: Cabral Collision Center provides a lifetime warranty, unless the manufacturing warranty is less, on new OEM parts installed. The shop warranty does not exceed the warranty of the original manufacturer. Cabral Collision Center will repair or replace any defective part warranted when claim is made to Cabral Collision Center unless caused by or damage results from unreasonable use, maintenance, care of the vehicle, or unrelated damage thereafter repairs have been made.

This written warranty shall be null and void if the repair is altered, adjusted, or tampered with by any person not authorized by Cabral Collision Center. This warranty is valid for the vehicle which has undergone original repairs and is not transferrable for any other vehicle.

## Specifically excluded:

- 1. Rust and/or damage caused by rusting or interior or exterior non-replaced panels are covered.
- 2. Paintless Dent Removal (PDR): Cabral Collision Center does not warranty PDR work performed due to the potential of microscopic damage to the paint in the area where PDR is performed.
